The Commission has exercised its discretion under subsections 34(1)(b) and (c) of the **Code** and has decided to not deal with this complaint which alleges discrimination in accommodation because of family status, marital status, receipt of public assistance and sex for the following reasons:

- The evidence indicates that the complainant has withdrawn her allegations with respect to family status, marital status and sex, and now relies only on the ground of receipt of public assistance.
- 2. The evidence indicates that the respondent creates the regulations that set out the formula for the levels of shelter allowance that will be received by persons who receive public assistance under the *Ontario Works Act, 1997* ("OWA"). The respondent applies this formula to the complainant in the same way that it does to all other persons who receive public assistance pursuant to the *OWA*.
- 3. The evidence further indicates that the complainant has failed to establish a social area with respect to the allegations against the respondent. The respondent does not itself provide accommodation to the complainant, but instead provides her with financial assistance. As a result, the complaint cannot be said to be "with respect to the occupancy of accommodation" within the meaning of the *Code*. Therefore the complaint is not within the jurisdiction of the Commission.
- 4. Given the totality of the evidence, in the particular circumstances of this case, the complaint can be characterized as vexatious.

For the above reasons, the Commission considers that the complaint falls within the provisions of subsections 34(1)(b) and (c) of the *Code*.

NOTICE TO COMPLAINANTS

Where the Commission has made a decision

- a) not to deal with a complaint under Section 34 of the Code, or

you have the right to make an application "request" for reconsideration of the Commission's original decision.

Your request must reach the Commission's office within 15 calendar days of the date of mailing of this notice and the enclosed decision.

If your request arrives at the Commission's office *past* the 15 day time limit, it *must* contain the special reasons why you believe the Commissioners should allow a late request. The Commissioners will then decide, in their discretion, if the extension will be granted. Failure to submit any or sufficient special reasons may result in the Commissioners not granting an extension or dismissing the request on that basis alone. *Extensions are not automatic*.

All requests for reconsideration must be in writing and must contain a *concise* statement of the material facts upon which the request is based.
